Where is e-labeling used?



- Hospital Use
 - Electronic Medical Records
 - Pharmaceutical department systems
- Non-Hospital Use
 - Local pharmacies
 - Pharmaceutical database company
 - Distributor
 - Universities, research institutions, etc.





What information does the hospital use?



- Labeling
- Appropriate use guide for Healthcare Providers
- Materials for Patients
- Materials provided by pharmaceutical companies
- Drug information database
 - Drug information databases maintained by database companies



Where to use medical care and labeling?

- Management of hospital-adopted pharmaceuticals
- Referring labeling
- Identification of drugs brought in
- Confirmation using patient information from EMR
 - Maximum dosage
 - Allergies
 - The number of days of administration




Examples of use of Drug information in the dept. system APAC Asia Partnership Conference of Pharmaceutical Associations

- Referring labeling
- Verification of prescription information using patient information
 - Contraindication
 - Drug-Drug interaction
- Preparation of product information for patients




E-labeling are now commonly viewed via smartphone apps.

Future Challenges





- Improved interoperability

 - Improve usability and interoperability.



Where are labeling from?








Basic concept of "Drug Information Service" in Hospital
